

CONDITIONS

Please note; you must read and understand the following terms and conditions before booking any tour.

BOOKING; a deposit of \$200.pp is required with booking form to book your tour. All payments should be made in the name of HARI TRAVEL PTY LTD.

FINAL PAYMENT; the balance owing on your trip must be paid by 28 days prior to departure date.

MODE OF PAYMENT; the cost of tour may be paid by Cheque, Cash, Bank cheque, Visa/Master Card. All Cheques/Bank Cheques should be made in the name of HARI TRAVEL PTY LTD

AMENDMNT FEES; once tour is confirmed you may request a). Amendments/changes at nominal fee of \$50pp. b). Transfer from one tour to another tour by paying the fee of \$200.pp.

INTERNATIONAL AIRFARES; The price of tour includes International Airfares to and from Sydney. We reserve the right to adjust/increase the price of each tour as per increase in Airport taxes/Surcharge/Levy, ground arrangements. Travellers flying to Sydney from other destinations to join the tour will be doing so at their own costs.

CANCELLATION AND REFUNDS; cancellation fee will apply as applied by Airlines tariff Regulations and vary depending upon the airfares purchased by traveller. All cancellations must be made in writing. Whereupon the amount you have paid will be refunded less cancellation fees per person which is based on tour departure dates.

a) More than 60 days of departure \$100. pp b) Less than 60 days before departure loss of full deposit. C).Less than 55 days before departure 30% of tour cost. d).Less than 40 days before departure NO REFUND.

CANCELLATION BY HARI TOUR TRAVEL PTY LTD; the HARI TRAVEL PTY LTD reserve the right to cancel any tour any time. In this case the amount paid by travellers will be fully refunded to the clients.

HEALTH AND INSURANCE; It is a condition of a tour confirmation that each passenger must obtain a appropriate standard of travel insurance which covers him/her for the duration of the tour, in case of medical injury, illness, death, loss of baggage, personal items, cancellations and curtailment.

SINGLE SUPPLEMENT; except while travelling in train, all accommodation will be twin share. However single bedroom may be requested at extra cost.

TOUR COSTS; The cost of each tour includes transfers to/from airport, accommodation in hotel or apartment, all meals, travel (by car or train), entry fees to sights, fees of tour guide.

POSSIBLE CHANGES AND OR DELAYS; The HARI TRAVEL PTY LTD reserves the right to alter the Itenary at short notice in the interest of the traveller, the local people or the environment.

COMPLAINTS AND SUGGESTIONS; In case you/travellers are not satisfied with the tour at any time you hereby agree to inform the local manager immediately. I confirm that I have read and understood this agreement prior to signing it.
